- Parents/Guardians/Caregivers are responsible for transportation to all of Sangha Education Center programs.
 - I, the Parent/Guardian hereby consents to Sangha Education Center’s use of photographs and/or audio or video recordings of my young adult for its publicity and marketing purposes. Sangha Education Center will never use my young adult’s name in conjunction with such photographs, audio or video recordings.
 - I, the Parent/Guardian hereby consent to allowing my young adult to participate in all activities and experiences that are part of Sangha Education Center for which my young adult is registered.
 - I, the Parent/Guardian understand that my young adult will be exposed to group activities and experiences that may be new to my young adult. I accept that my young adult’s participation in activities and experiences are made in full knowledge of their inherent risks and perils.
 - I, the Parent/Guardian have read, understand and agree that myself and my young adult will follow the documented COVID-19 guidelines outlined and required by Sangha Education Center in alignment with CDC and NYS.
 - I, the Parent/Guardian, hereby guarantee my young adult’s medical fitness as a prerequisite to my young adult’s participation in Sangha Education Center activities and experiences. Further, as a condition of my young adult’s participation, I hold harmless, severally and individually, Sangha Education Center and its staff, consultants, mentors, interns, mentors, volunteers, community partners, and agents from any and all damages, expenses or liability resulting from or arising out of the young adult’s participation in Sangha Education Center programs, activities, and experiences.
 - In the case that a program participant is an adult (18 years of age or older), they are agreeing to the terms of this Agreement and understand that all items listed herein apply to them. Parents/Guardians are agreeing to the terms of this Agreement as well, since responsibility may lie with them.
 - Sangha Education Center reserves the sole and exclusive right to dismiss program participants and all others involved with Sangha for improper conduct and/or behavior of any kind either by themselves, their siblings or parents/guardians/caregivers. Reasons would include, but are not limited to: persistent incivility to staff or other participants or misuse of materials.
 - Sangha Education Center is not responsible for any damaged, lost, or stolen property.
 - This Agreement shall be governed by and construed, enforced and interpreted under the laws of the State of New York, without regard to its laws relating to conflict or choice of laws. Any controversy or claim arising out of or relating to this Agreement, or the breach thereof, shall be resolved through Alternative Dispute Resolution mechanisms. The parties will first make a good faith effort to resolve any issues through mediation. Should such mediation not succeed, the parties will proceed to binding arbitration in accordance with the Rules of the American Arbitration Association of the State of New York, and any award rendered by the arbitrator shall be treated as a final and non-appealable judgment of any court having jurisdiction thereof. Each party shall bear its own costs and attorney fees, unless the mediation and/or arbitration award specifically provide(s) otherwise.
